DIRECTIONS FOR USE

Saatichem Remove ER1

Dissolve Remove ER1 in water. Add 1 part Remove ER1 to one hundred parts water for normal use and 1 part Remove ER1 to fifty parts water to reclaim more stubborn stencils.

Saatichem Remove 2

By volume, dissolve one part Saatichem Remove 2 in 35 parts water (1 to 25 by weight).

Saatichem Remove 4

Ready-to-use gel.

Saatichem Remove 5

Shake well before use.

Saatichem Remove 10

By volume, dissolve one part Saatichem Remove 10 in 80 parts water (1 to 50 by weight). Apply any Remove product liberally to both sides of a wet, ink-free screen using a brush or a sponge. Let stand for 1 to 3 minutes. To speed-up removal, rub with a nylon brush. Do not allow solution to dry on screen. Use pressure washer to remove all traces of the stencil.
